Application Deadline	Recommended deadline for all Applications. The timeframe permits City review of the application, time for the applicant to conduct a Neighborhood Meeting, if requested by the City, and for the applicant to complete any requested revisions.	Ensure all required materials are provided with the application. Concept Plan Reviews and informal consultation by staff prior to application submittal is encouraged to forecast City requirements, including Neighborhood Meeting requirements, which may impact project timeline. Late Application Deadline	Applications which are complete, routine, and where the City does not request a Neighborhood Meeting may be accepted up to this date.	
Notification & Revision Deadline	In order for applications to be placed on a Board of Commission agenda, ALL of the following must occur <b>by this date:</b> <ol style="list-style-type: none"> <li>1. Any neighborhood meetings required by the City shall be completed.</li> <li>2. Any missing information or required revisions must be submitted to the City</li> <li>3. Notification signs must be picked up and posted on the subject property.</li> </ol>	Applicants are responsible for providing all required information, conducting all outreach, and posting notification signs on the property by this date.  Failure to meet all of these requirements may result in the case being delayed to the next month.
Review and Recommendation	City Planning Commission will hold a Public Hearing to review and provide a recommendation on the application.	<b>Attendance at this meeting is expected. Forecast any issues with the City</b>
Set Public Hearing	City Council consent agenda item to set a future Public Hearing	Applicants are not expected to attend this meeting.
Public Hearing and Decision	City Council or Board of Adjustment meeting to conduct a Public Hearing and provide a final decision on an application	<b>Attendance at this meeting is expected. Forecast any issues with the City</b>
2nd & Possible 3rd Ordinance Reading	Rezoning requires adoption of an ordinance, which requires multiple readings on multiple dates. Typically the 2nd and 3rd Ordinance Reading is combined at the second Council Meeting.	Staff will discuss with applicants if attendance is expected.
